

The hand cart will consist of one vertical support of 0.45.meter long of M.S angle 40 x 40 x 6mm and one pipe 40 mm dia one meter long size connecting with MS-Tee of sides 75 x 75 x 10 mm of length 1 meter for pulling and MS flat size 40 x 3mm fixed with the sides of the hand cart for support & two wheels with rubber cover ball bearing, shaft of approved make. The Hand Cart shall be painted with primer & two coat of synthetic enamel paint of dark grey colour completed in all respect as per direction of E.I.C.



2. The authorized representative may present at the time of opening the tender.
3. The rates of this quotation will be valid for 90 days. The rates offered in the quotation form shall only be considered. The rates offered on any other paper shall not be considered. The items quantity Shown in the list may vary according to the actual demand/requirement.
4. The earnest money by way of Bank draft /FDR valued **Rs.8500/-**only in favour of the Secretary , APMC , Azadpur is required with the quotation failing which the quotation will be treated as rejected . It should also be noted that EARNEST MONEY IS MANDATORY .
5. The rate quoted should be written in figure and words including VAT/Taxes etc.
