### **CIRCULAR**

Therefore, all the licensees dealing in **Mosambi** in APMC (MNI) Azadpur are hereby advised to furnish information of market fee for **Mosambi only** on an affidavit/undertaking as per performa attached.

In case, any wrong information is furnished, the claim of trader for allotment of phars/space shall not be entertained. In case of difference in market fee the trader should clearly mention reason. The allocation will be done on the basis of average market fees paid for **Mosambi** in the last three financial years.

The affidavit/undertaking should reach to this office by **18-11-2022 upto 5.00 PM**. APMC reserves the right to consider/not to consider the temporary space allocation for above said commodity given the availability of space.
