### CIRCULAR

Temporary allocation of space for the trade of **Mosambi trade only at Shed No 15 & 16 NFM Azadpur** are under consideration in this office. All licensees who deals in **Mosambi** commodity only have to submit Affidavit/undertaking containing the details of deposited Market Fees of **Mosambi** for the last three financial years (2020-21, 2021-22 & 2022-23).

Therefore, all commission agents dealing in **Mosambi only** in APMC(MNI) Azadpur are hereby advised to furnish information of market fee of **Mosambi only** on an affidavit/undertaking format duly self-attested as per Performa attached. They are required to furnish the information correctly as per record mentioned by them.

In case any wrong information is furnished, the claim of the commission agents for allotment of phars/space shall not be entertained. In case of difference between market fee as per trader's book and that deposited in APMC, the commission agents should clearly give the reason for it. The allocation will be done as per the average market fees paid for **Mosambi** of the past three financial years.

The affidavit/undertaking should reach this office by **25.11.2023 at 05:00 PM**. APMC reserves the right to consider/not consider the temporary space allocation for above said commodity or to any commission agent in view of availability of space.
