### Minutes of Jan Sunwai

In pursuance of letter dated 10.03.2016 received from Dy. Director (AM), Directorate of Agricultural Marketing, Govt. of NCT of Delhi, a meeting of Jan Sunwai was held on 14-03-2016 at 2.30 P.M. in the office complex in APMC (MNI), Azadpur which was chaired by the Secretary, APMC(MNI). In addition to the conventional meeting notice, SMS were also sent on mobiles phone for Jan-Sunwai. Market functionaries were present in large number during the Jan-Sunwai.

1. Secy (MNI) reviewed the minutes of last Jan Sun-Sunwai held on 16.02.2016 & briefed people present about the action taken on the main issues raised in the meeting.
2. Sh. Umesh Kumar, Potato Commission Agent made following suggestions:-
  - a) Standard format of under taking be placed on the web site of APMC Azadpur.
  - b) Civil defence Volunteers are creating problem for regular employee in discharging their duties. It should be stopped. They should stick to their duties only.
  - c) D Block internal roads be repaired immediately and carpeting be made from concrete instead of ceramic tiles in the inner lanes of block.
  - d) New Sewer line be installed in all the four A,B,C, & D Blocks of NSM Azadpur as per the present sewerage system is remained generally choked thought the year & out dated .

(Action:-Ds.IT/Ds.CT/Ds.Security/EE. Civil)

3. Sh. Yogesh Sonkar, Commossion, Agent draw attention towards following points:-
  - a) Lighting arrangement in D Block be made though LED bulbs,it will not only save electricity but save money also.
  - b) Illegal shed in front of B block known as kheera shed must be removed because it is dangerous and can be fallen on any person during stormy winds.
  - c) In front of A Block encroachment must also be removed.
  - d) Letter be written to agency maintaining Sulabh Souchalaya for its repairing/ maintenance.

- e) Issue of pending Licences due to change of constitutions be disposed off on priority basis because in the last meeting of marketing committee no agenda of Licence branch was approved.
- f) People are using Chemical on Kathhal & mango while selling it , this should not be allowed in Mandi.

**(Action:-EE. Electrical/EE. Civil/Ds. Enf./Ds. Lic.)**

- 4 Shri Pardeep Sonkar of D-382 informed that he has applied for change of constitution in his licence, but he has not received amended licences even after passing of long time.

- 5 Shri Sanjeev Kumar, President of Sharda, Tarbooj requested that allotment of space be to the Sharda Tarbooj traders on priority basis as the peak season of these commodities is starting in near future.

**(Action:-Ds. E&M)**

- 6 Sh. Yogesh Sonkar, Comomission, Agent raised the issue of period of renewal of licence from three year to five or ten year.  
Shri N.P. Rai, DS (Lic.) informed that as per Act , renewal period of B-Category licence is one year, however Marketing Committee has extended it upto 3 years.

7. Sh. Umesh, Potato Commission Agent drew attention towards followings:-

- a) APMC should adopt uniform policy in charging phar fees in Onion trade and other trades as well.
- b) Multi level toilets be constructed in APMC, Azadpur due to the paucity of space in Mandi.
- c) 15 cemented bench each be installed in both the parks of APMC, Azadpur so that people working in Mandi can relax during free time.
- d) Steps be taken for opening of New Dispensary in Mandi, a reminder be issued to the Health Department in this regard.
- f) All the Commission Agents be issued licence on good quality laminated sheet instead of poor photocopy paper.
- g) Possibility be explored for underground parking in shed no.17 and 18 so that problem of parking be resolved in the Mandi.

8. On AB Chowk & on entry road of NSM, Azadpur encroachment should also be removed for the smooth movement of traffic in the mandi.

9. Issue was raised regarding deteriorating law and order problem in Mandi and it was suggested by the participants that in meeting of Jan Sunwai area SHO also be invited so that he may be briefed about the law and order problem in Mandi.

10. Possibility should also be explored that CCTV Camera system of APMC, Azadpur be installed in whole Mandi.
