

Minutes of Jan Sunwai

In pursuance of e-mail dated 04.05.2016 received from Dy. Director (AM), Directorate of Agricultural Marketing, Govt, of NCT of Delhi, a meeting of Jan Sunwai was held on 20.05.2016 at 2.00 P.M. in the office complex in APMC (MNI), Azadpur which was chaired by the Secretary, APMC(MNI). In addition to the conventional meeting notice, SMS were also sent on mobiles phone for Jan-Sunwai. Market functionaries were present in large number during the Jan-Sunwai.

1. Sh. Pritam Singh, Commission Agent made following suggestions:-
 - i) Water remains stagnant in A,B,C & D Block, during the raining season therefore, steps should be taken to avoid any untoward situation during rainy season.
 - ii) Sewer drainage system is totally choked in the all the four blocks of N.S.M Azadpur & needs immediate attention of the concerned authorities of APMC Azadpur to ease the situation.
2. Sh. Anand Kumar Goyal of the firm M/s Om Prakash & Co., Shop No. A-260 also informed that sewer in A-Block is totally choked & need immediately remedial measure.
3. Sh. Vijay Kapoor, Shop No. D-1309, Licence B-2985 made following suggestions:-
 - i) Road from Ganna Shed to Tomato Shed is broken & there are pot holes on all the stretch of the road.
 - ii) In Shed No: 12- Mashakhori are sitting & they blocked the road around shed no 13 by placing their commodity on roads.
 - iii) A regular unauthorized tempo parking has been made in front of Tomato shed which causes traffic jams in the area.
 - iv) Tempo are repaired on regular basis in the end of shed no 17.
 - v) Some people drinks wine/liquor on the phar of different sheds.
 - vi) Allotment of space in D-Block shed should make on priority basis.
 - vii) Water Trolleys are parked on road and sells water while standing on road causes traffic jam on road.

4. Sh. Umesh Kumar, Potato Commission Agent made following suggestions:-
- Rainy season is approaching, desalting should be completed before rainy season.
 - In shed no. 13 fruit association of NFM collects a large amount of money regular basis from the working Mashakhor.
 - Poma Shed should be renamed as Onion Shed.
 - There is no canteen in APMC complex, labour licence commission agents visit office complex, but there is no facility of canteen. It should be provided.
 - In office, there is shortage of printer copier and scanner which causes delay in office work.
 - In shed no 14 wander charges more than the MRP, it should be stopped.
 - Details of assessment completed of the firm must be displayed in the website of APMC, Azadpur.
 - Letter be written to RCS department against the associations , which are not conducting the mandatory election .
5. Sh. Siya Ram, Market activity inform that SMS are received twice for one commodity arrival but it was clarified that some time message are sent twice but not received by Licencee due to transmission problem.
6. Sh. Rakesh Sachdeva, Onion Commission agent has requested that space be provided to the onion trader who registered after the year 2014-15 in APMC Azadpur.
7. Secy. (MNI) asked all traders not to use chemical in ripening of fruits & vegetable.
