MINUTES OF JANSUNWAI

As scheduled meeting of Jansunwai was held on 23.05.2018 at 12:00 Noon in the Conference Hall of APMC (MNI) Azadpur which was chaired by Chairman, APMC (MNI) Azadpur. The issues raised during Jan-Sunwai are as under: -

1. Sh. Sumit Kumar Proprietor of firm M/s. Nand Kishor Sumit Kr., Shop No. B-743, Lic. No.B-130 requested for restoration of his 'A' category licence. Earlier A & B Category of his licensee were suspended due to non-arrival of commodity.

Action: DS (Lic)

2. Sh. Mahesh Kr. Sahani, Shop No. A-259, requested for restoration of his A Category Licence. Earlier A & B Category of his licensee were suspended due to non-arrival of commodity in the year 2017.

Action: DS (Lic.)

3. Sh. Bijender Tyagi, prop. of the firm M/s. Devinder Kr. Bijender & Co., Shop No. D-1310 requested for auction space in Green Vegetable. He also informed that some traders have given their phar on rent basis where as APMC has given free of cost.

Chairman (MNI) asked DS (Enf.) to conduct the survey & submit the report.

4. Sh. Jagparvesh proprietor of the firm M/s. Giriraj Fruit Co., Shop No. D-1295 requested for provision of space for organic vegetable in Sangam Shed the APMC, Azadpur Mandi.

5. Sh. Lalit Kr. From M/s. Neelkant Traders raised the issues as under:-

- (i) Allocation of auction spaces in Anar shed be made on priority basis.

Chairman (MNI) informed that allotment process of auction space in Anar trade is under consideration and allocation in Anar trade be made shortly.

- (ii) Requested for cleaning in D Block area near dhallow of this D-Block.

6. Sh. Amit Bansal from Shop No. A-281 informed that sewer lines are chowked in A & D Block of NSM Azadpur & need immediate remedial action.

Chairman (MNI) informed that tender for awarding the work of New Sewer system in A & D Block is under process.

7. The prop. of the firm M/s. Pritpal Singh Darshan Pal Singh & Sons, informed that his lincece was not transfered from the address of Shop No. A-322 to A-332 NSM, Azadpur. He has applied for this for long time ago.

Dy.Secy. (DSC) informed that there is Dispute case pending against the said shop.

8. Sh. Akeel Ahmad from Shop No. A-341 raised the issues as under:-

(i) Requested for auction space in mutter shed.

(ii) Some outside person are taking money from the drivers of the vehilces entering in the market & allowing them to go without gate pass.

Chairman (MNI) asked to verify the status & take the action accordingly.

9. Sh. Manoj Kumar from Shop No. C-533 requested for auction space in Green Coconut.

Action : DS(Gate)

10. Sh. Virender Rana commission agent informed that computer & printer at the gates are very old due to which there is a problem in issue the gatepasses and because of that there is a traffic jam at gates.

Chairman (MNI) directed to provide computer at gate No.5, 5A & 1 & stand by printer.

Action : DS(IT)

11. Sh. Umesh Kr. Potato commission agent from Shop No. A-266 raised the following points:-

(i) Desalting of sewer lines in A, B, C & D Block.

EE (C) informed that work of desalting of sewer lines in A, B, C & D Block in under process.


Action : DS(Gate)
