## MINUTES OF JANSUNWAI

As scheduled meeting of Jansunwai was held on 24/07/2019 at 3:30 PM in the Conference Hall of APMC (MNI) Azadpur in the presence of different stake holders & officers of APMC(MNI) Azadpur. The issues raised during Jan-Sunwai are as under: -

1. Sh. Sandeep Khandelwal, potato traders from M/s Om Shyam Trader, shop no. A-1137 raised the issues as under: -

- (i). He informed about the encroachment near shop no. A-1137 due to re-packing of lemon mostly between 2 to 6 P.M.

Action: DS (Enf.)

- (ii). He informed that some of the traders selling the Cemented & Clay coated Potato in shed No. 14 which is harmful for the human life. He also stated that no action is taken by APMC in his earlier complaint.

Sh. Shyam Lal, DS asked AS (Enf.) to call the meeting with the trader of potato.

- (iii). He raised the issue of encroachment near Sulabh Sochalaya in NFM.

2. Sh. Pritam Kumar, Shop No. B-235 of M/s Jagram & Co., raised the issue as under: -

- (i). He informed that Mashakhor selling the goods on the road at A, B, & D chowk to B-235 due to which there is an encroachment and traffic jam.

- (ii). He informed that road of A, B & D is broken and need immediate repair & also requested for Black Mastik Layer on the road.

- (iii). He raised the issue of stray cow in the mandi.

- (iv). He also requested to depute the ladies security personal to remove the ladies encroachers in NSM.

(vii) He informed that the vehicle of mother dairy near shop no. C-1 was not parked properly due to which there is a traffic jam.

(viii) He raised the issue of insanitary condition in Kheera shed and from Shop No. D-403 to D-436.

Action: DS(Sanitation)


(ix) He informed that drain is overflow near adjoine of PWD connection at Entry gate due to small in breath & need immediate remedial action.
