MINUTES OF JANSUNWAI

As scheduled meeting of Jansunwai was held on 26.12.2018 at 3:00 PM in the Conference Hall of APMC (MNI) Azadpur which was chaired by Secretary(MNI) & Sh. Anil Ghidyal, Secretary, FMC, Gazipur was also present as an Observer. The issues raised during Jan-Sunwai are as under: -

1. Sh. Yogesh Sonkar, representative of the firm M/s. Raj Kishan & Sons, Shop No. D-418 raised the issues as under: -

(i) He requested for allotment of Kheera commodity in Matar Shed.

Action: DS(E&M)

(ii) He informed that Sewer lines are chowked in A & D block of NSM Azadpur & need immediate remedial action.

EE (C) informed that the work for change of sewer line will be start within 2 days.

Action: EE(C)

(iii) He also requested for installation the Security Booth near Transformer at shop No. D -438 to stop encroachment & unauthorized parking.

EE(C) informed that the booth is ready and will be installed after examine of traffic movement.

Action: EE(C)

(iv) He requested for installation of Electric lights adjacent to the wall of Bharolla from D-403 to D-438.

Secretary (MNI) asked EE(E) to examine the matter within one week & proposal be put accordingly.

Action : EE(E)

(v) He informed that in D block near Transformer mashakhori sitting on the road unauthorisely which creates problem in traffic moments.

Secretary asked DS (Enf.) for special encroachment drive in morning shift & also ordered to remove encroachers & deploy 2 security personal round the clock near transformer in AB chowk, NSM Azadpur.

Action: DS(Enf.)/EE(C)

(vi) He informed that Kheera traders are operating from tin shed (Kachha) at B-Block parking and further requested that a permanent shed (Pakka) may be constructed in place of temporary shed & as has been done in Mater Shed.

Action: EE(C)

(vii) He informed that there are a dark spot outside the Mandi & electric bulb be installed there.

Secretary (MNI) asked EE(E) to resolve the problem immediately.

Action: EE(E)

(viii) He requested for allotment of Green Vegetable in Sangam shed at D Block.

DS(E&M) informed that presently shed No 2 has been given temporary to Lemon trade & Growers because onion shed is under construction and will be completed after February thereafter Green vegetable allotment in shed No 2 will also be re-constructed & hence allotment of Green Vegetable will take place after that.

Action:DS(E&M)

(ix) He draw kind attention towards Juvenile crime in mandi.

Secretary (MNI) asked to juvenile write a letter to Delhi Police to control the Juvenile Crime.

Action: EE(C)

2. Representative of the firm M/s. Banke Bihari Fruits, Shop No.C-677, Lic No. B-4797 requested for auction space for tarbooj commodity.

DS(E&M) inform that allotment for Sharda & Tarbooj is under process.

Action : DS(E&M)

3. Sh. Akeel Ahmed of Shop No. A-341 raised the issues as under: -

(i) He requested for allotment of Matar Shed.

Secretary (MNI) asked DS (E&M) to examine the matter.

Action:DS(E&M)

(ii) He requested that instructions be issued to the gate staff of APMC that without bilty gate passes should not be issued.

Action: DS(Gate)

(iii) He informed about unauthorized parking in cement go-down near Sulabh Sochalaya is making traffic jam.

Action: EE(C)

(iv) He requested that gate near tomato shed may also be opened after construction of cement go-down to resolve the traffic jam problem in this area.

Action: EE(C)

4. Sh. Jagdish representative of Jai Bhole & Co., Shop No. D-1253 requested for allotment of space in Matar Shed.

Secretary (MNI) asked DS(E&M) to examine the matter.

Action: DS(E&M)

5. Representative of M/s. Bharat Trading Co., Shop No. A-1048 requested for auction space for Onion.

Action: DS(E&M)

6. The representative of M/s.N.P. & Co., Shop No. A-1019, Lic No. B-2686, M/s. Prem Babbar Bharat Babbar, Shop No.A-1092, Lic No.B-6072, M/s. Mehar Sai Fruits, Shop No. C-549, Lic No.B-3703, M/s. Kashmiri Lal Surinder Kr., Shop No.A-261, Lic No. B-1679, M/s. Deepak Kumar Tirlok Chand, Shop No.A-261, Lic No. B-1429 informed that they was allotted $\frac{3}{4}$ phar for Mosambi Trade which is too small to manage day to day activity which is necessary to sell Mosambi as the goods sold after shorting & grading. They also informed that Mosambi are received in loose & thereafter packed in katta which is in cylindrical form, hence it is not possible to stack them vertically. Therefore, they requested to increase the space from $\frac{3}{4}$ phar to One phar.

Action: DS(E&M)

7. Sh. Sandeep Khandelwal, for M/s. Om Shyam Traders, Shop No.A-1137 raised the issues as under:-

- (i) He informed that some of the traders selling the cemented & clay coated potato, which is harmful for the human life. He also sought the status of his earlier complaints.

DS(Enf.) informed that sample has been sent to DAM (Lab) & action will be taken after receiving the lab reports.

Action:DS(Enf)

- (ii) He informed that some of the trader of A-Block cutting the lanter of roof & prepare the room the action be taken against the people.

Action:DS(Enf)/EE(C)

8. Sh. Umesh Kr, Potato Commission agent from Shop No. A-266 raised the following points.

- (i) He raised the issue of selling the liquor illegally opposite Kissan Bhawan.

Secretary (MNI) asked DS(Enf) to write a letter to Delhi Police to resolve the problem.

Action:DS(Enf)

- (ii) He informed about the broken foothpath & Dark spot in around Hira Singh Park. He requested for installation of double handed electric pole to resolve the dark spot problem.

Action: EE(C)/EE(E)

- (iii) He informed that street lights are not installed in A, B, C & D block since long.

EE(E) informed that 4 Bid from Gems conducted but material has not been supplied by the contractor. He also informed that issue of next bid is under process. Secy.(MNI) asked EE(E) to write a letter to Gem for black list of defaulter suppliers.

Action: EE(E)

- (iv) He requested for installation of the Dalla lights of shed No.13.

Secretary (MNI) asked EE(E) for survey of whole mandi to resolve the problem of Dalla lights.


Action : EE(E)
