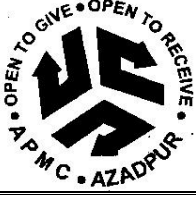

The sealed quotations will be opened on the same day at **3.00 p.m.** in the office of Executive Engineer(E), APMC Azadpur in the presence of the quotationers or their authorized representatives, who may like to attend. Quotations received after the prescribed time and date shall not be considered.

The earnest money as indicated above shall have to be deposited by the tenderers / quotationers along with the application for issue of tenders/quotations by a Bank Draft or Pay Order in favor of **APMC, Azadpur.**

The tender/ quotations forms and other contract conditions can be obtained from the office of the undersigned on any working day up to the last date of issue of tenders as indicated above on furnishing receipt of cost of tender/quotation papers(in cash) and earnest money as specified above. The GST Registration Certificate, PAN No, experience of having completed successfully at least one work of similar nature and

magnitude equivalent to the value of estimated cost of works as mentioned above, are to be shown before the issue of tender/quotations documents and attested true copies of the same are to be enclosed with the request for issue of tender/quotations documents.

The NIQ can be seen on web-site www.apmcazadpurdelhi.com. The firms downloading quotation papers from website will have to submit offers in two packet system consisting cost of tender/quotation papers and earnest money along with attested copies of certificates as prescribed above in support of eligibility in one envelop Marked 'A', while quotation form/price bid shall be placed in another envelope subscribed as annexure 'B'. Both these above sealed envelopes shall be kept in separate bigger size sealed packet mentioning name of work, and due date of opening otherwise tenders shall be treated as invalid & rejected. The price bid of agencies which does not qualify in eligibility criteria shall not be opened and decision of competent authority shall be final and binding upon all parties. APMC reserves the right to reject any or all the tenders without assigning any reason.

Terms & Conditions

1. The rates quoted should be inclusive of GST , ,Cartage and other levies and duties on the price of the materials and nothing extra on this amount shall be payable by the department.
2. The condition of DG Set should be in perfect condition.
3. The payment shall be made only after successful completion of work.
4. The contractor shall make his own arrangement at his own cost for electric/general tools and plants required for the work.
5. Co-ordination/follow-up/complaining etc. with TPDDL is to be kept in case of failure /fault in supply/fluctuation in voltage etc. The contractor shall intimate the EIC about the major break down/repairs to be carried by TPDDL.
6. The Vendor will have to provide the services of an operator / wireman having the necessary skill level for operation and routine attention to the Genset. Generator services will have to be provided for 24 hours on all days. The staff should have knowledge of electrical work and shall also be responsible for repair/rectify the electrical fault in check post and street lights in addition of operation of DG Set.
7. All kinds of maintenance including periodical servicing of the Generator set and arrangement of Diesel & Mobil oil required for daily running of the Generator Set , shall be the responsibility of the vendor.
8. The vendor will have to supply and install suitable length, size & capacity armored aluminum cable for connection from the generator MCCB /change over switch to control panel of APMC.
9. The rates quoted shall be stand valid for 90 days.
10. Department reserves the right to reject any or all quotations without assigning any reason thereof.
11. Conditional quotations are liable to be rejected.
12. Loss of life/damages/accidents etc. shall be the sole responsibility of the contractor and no compensation shall be payable by the department.
13. The contractors shall be entirely responsible for any accident or injury to any personnel including the Gen Set operator due to installation / operation of the generators and shall completely and totally indemnify the APMC of any responsibility by entering into the contract for the work.
14. If the services of the contactor are found unsatisfactory, the APMC reserves the right to terminate the contract after giving one month notice.
15. The vendors are requested to acquaint themselves with the site conditions, terms & conditions, schedule of items and technical specifications of the quotation and should seek requisite clarifications, if required, from concerned E-I-C before quoting the rates.
16. The vendor shall not assign the contract to anyone else. He shall not sublet any portion of the contract.
17. The rates quoted by the vendor shall be firm & fixed and no variation will be allowed in rates on any account. The rate quoted should be inclusive of all taxes, duties, levies, cartage etc. imposed by the Central, State Govt. or Local administration and as applicable or becomes applicable during the contract period.
18. Proper and timely maintenance of DG set, cable and all other material given on hire by the contractor shall be the total responsibility of the contractor giving the DG set on hire.

19. The charges for transportation, loading & unloading and installation of the D.G sets in APMC premises will be borne by the supplier. Mending of any damage caused to the APMC property during loading, unloading & installation of the D.G. set in APMC premises will be done by the contractor to original finish at his cost.
20. It shall be entirely the contractor's responsibility to ensure compliance/conformity to any related statutory obligations like those pertaining to pollution or electrical safety.
21. In case of break-down of D.G. set, alternative interim arrangement will have to be made by the vendor within four hours by providing substitute generator (S) of adequate capacity at no extra cost. In case vendor fails to make alternative, interim Generator set arrangement, APMC will impose penalty at double the pro-rata rate to be deducted from monthly bill of the generators for the period the generating set remains nonfunctional.
22. The deployment of operator for running the generator sets should comply with all the Labour Legislations like Minimum Wage Act etc. of the State Govt.
